

# Allowed discharge current of energy storage cabinet battery

How long can a battery be discharged?

Maximum 30-sec Discharge Pulse Current -The maximum current at which the battery can be discharged for pulses of up to 30 seconds. This limit is usually defined by the battery manufacturer in order to prevent excessive discharge rates that would damage the battery or reduce its capacity.

What is maximum continuous battery discharge power to empty state?

3.3.10. Maximum continuous battery discharge power to empty state  $P_{Bat,cont,D,max,empty}$  Maximum continuous battery discharge power to empty state is the maximum discharge power of the battery, which is continuously applicable at the battery terminals till reaching empty state.

How to calculate battery discharge power to empty state?

Typically maximum continuous battery discharge power to empty state is given by (24)  $P_{Bat,cont,D,max,empty} = I_{Bat,D,finish} \cdot V_{Bat,EOD}$  wherein  $I_{Bat,D,finish}$  is the finishing discharge current and  $V_{Bat,EOD}$  is the battery end-of-discharge voltage of the cell or battery as declared by the manufacturer ( $V_{Bat,EOD} > 0$ ).

How far from Battery cabinets can combustible materials be stored?

Combustible materials in occupied work centers covered by Section 1206.2.8.5 shall not be stored less than 3 feet (915 mm) from battery cabinets. Storage batteries and associated equipment and systems shall be tested and maintained in accordance with the manufacturer's instructions.
