What rating should a battery cabinet have?

Indoor battery cabinet should have at least NEMA 1 rating. On the other hand, outdoor enclosures for batteries should have a NEMA 3R rating. What should a battery cabinet have?

Handles - provides an easy way to handle the battery cabinet. Battery holding brackets - they ensure the battery is always in a fixed position (no movement). Cooling plates - some have cooling plates that help to control the enclosure temperature. Insulation system- insulation is also a safety measure a battery cabinet should have.
