Does Botswana have a customs tariff?

Botswana's customs tariff regime includes special duties and exemptions based on trade agreements and the origin of the imported goods. Goods imported from countries outside of the SACU region, such as China, Japan, and the United States, are subject to Botswana's common external tariff (CET).

Does Botswana impose tariffs on electrical equipment?

Electrical machinery: Subject to 5% to 10% tariffs, depending on the equipment. Botswana imports most of its vehicles, both for personal and commercial use, from countries like South Africa and Japan. The country applies tariffs on these imports to regulate the automotive market and protect local vehicle assembly industries.

Does Botswana have duty-free imports?

Southern African Customs Union (SACU): Botswana benefits from duty-free imports of most goods from other SACU member states. Southern African Development Community (SADC): Under the SADC Free Trade Area (FTA), Botswana enjoys reduced tariffs or zero tariffs on goods traded with SADC member countries, such as Zimbabwe, Mozambique, and Zambia.

How are import duties calculated in Botswana?

Import Duties: Botswana imposes import duties on a wide range of goods, with rates varying depending on the product type. Customs duties can be calculated as a percentage of the customs value (the price paid for the goods plus shipping and insurance).

How to import from Botswana?

Importing from Botswana requires proper customs declarations, country of origin documentation, HS code classifications, and payment of the 15% tariff rate along with any other applicable duties and taxes.
