What is the National Energy Policy in Botswana?

The National Energy Policy (2021) and the National Energy Efficiency Strategy (2018) provide the policy framework for energy efficiencyin Botswana. BERA is the institution in charge of energy efficiency regulation and the Department of Energy is responsible for the formulation, development, and implementation of an energy efficiency strategy.

Can Botswana meet its energy needs in 2021?

According to the International Renewable Energy Agency (IRENA), Botswana could meet 15% of its energy needs in 2030 from its indigenous solar, wind, and bioenergy resources. (2021 evaluation)

How is electricity used in Botswana?

Electricity can be generated in two main ways: by harnessing the heat from burning fuels or nuclear reactions in the form of steam (thermal power) or by capturing the energy of natural forces such as the sun, wind or moving water.

How much solar energy does Botswana use?

Botswana has tremendous potential for solar energy utilization, with an annual Direct Normal Irradiation equivalent of 3,000 kWh/m²/ain most parts of the country, with an average insolation on a horizontal surface of 21 MJ/m².

Is Botswana eligible for electricity trading through the SADC energy protocol?

Through the SADC Energy Protocol, member states are required to work towards regional integration and cooperation in energy development and as part of this regional integration, Botswana is eligible for electricity tradingmainly via the Southern African Power Pool (SAPP). 3.6.1 Energy and environment
