What is the future of solar energy?

The growth of U.S. solar will require continued research and development investments in new solar materials, solar demonstration projects, critical material supply chains, and the building or retooling of manufacturing facilities for the production of advanced energy technologies.

Will rising shipping and equipment costs postpone or cancel solar projects?

Analysts at the consulting firm Rystad Energy estimate rising shipping and equipment costs are threatening to postpone or cancel 56% of worldwide utility-scale solar projects planned for 2022. Given these items represent as much as one-third of project costs, even a small price can turn a narrowly profitable project into a money-loser.

When will a solar project be placed in service?
