Value Added Tax is associated with these imported products. VAT is payable at 17%. - Residents of St. Kitts/Nevis who were abroad for a period exceeding seven (7) days are entitled to a E.C.\$400.00 allowance on items, excluding firearm (s) and or ammunition, acquired or purchased overseas.


