What's going on with Bess in Canada?

Elsewhere in Canada, other BESS-related advancements have been pouring in. In May, the government of Ontario completed the largest battery storage procurement in Canadian history. It secured 2,195 MW from ten projects ranging in size from 9 MW to 390 MW.

Where is IESO building a Bess power plant?

The contract is one of seven BESS awards totalling 739 MW in a recent capacity procurement by IESO. The BESS facility in east Greater Napanee, southeastern Ontario, will be built adjacent to Atura's Napanee Generating Station and Ontario Power Generation's Lennox Generating Station.

What is the largest energy procurement in Canadian history?

The almost 1,800 megawatts of BESS projectsmake up an energy procurement round from IESO that totals 2,195 megawatts of capacity, including 411 megawatts of natural gas and on-farm biogas generation. The Ontario government claims the deals make up the largest battery storage procurement in Canadian history.
