

# Communication Green Base Station Inspection Requirements

What are NEBS requirements?

BTS sites (Base Transmitter Station), cell sites, cellular towers and telecommunications centers must provide highly reliable phone and data communications, and in order to maintain this level of service the equipment and grounding must meet NEBS requirements (Networks Element Building Standards).

What is a base station inspection (BSI)?

The typical base station inspection (BSI) services include: Dangerous to the life safety of the base station inspection personnel. The personnel climb the base station tower to perform close-range inspection on the tower body, antenna, feeder, bracket and other components, which is a long-term, high-intensity and high-altitude operation.
