Why is Greece turning its attention to energy storage?

This year the country is expected to score an even higher percentage of renewable electricity, although this success is accompanied by the thorny issue of curtailing surplus green electricity at times when the electricity system cannot accommodate it. Therefore, rather belatedly, Greece has turned its attention to energy storage.

Should Greece invest in energy storage facilities?

Currently there is a growing interest for investments in storage facilities in Greece. Licensed projects mostly consist of Li-ion battery energy storage systems (BESS), either stand-alone or integrated in PVs, as well as PHS facilities.

A call for the program's third tender, targeting specifically battery systems in former coal mining regions, is imminent.

What will Greece's energy storage capacity be in 2025?

The combined capacity from all three auctions is expected to reach 900 MW. These energy storage units are crucial for Greece to manage renewable energy curtailments, which have already reached 3.7% this year and are projected to increase further in 2025.
