What is required working space in and around the energy storage system?

The required working spaces in and around the energy storage system must also comply with 110.26. Working space is measured from the edge of the ESS modules, battery cabinets, racks, or trays.

What if energy storage system and component standards are not identified?

Energy Storage System and Component Standards 2. If relevant testing standards are not identified, it is possible they are under development by an SDO or by a third-party testing entity that plans to use them to conduct tests until a formal standard has been developed and approved by an SDO.
