How can energy storage products be integrated?

Does the energy storage strategic plan address new policy actions?

Do energy storage systems need a safety assessment?

Safety Assessment: As more energy storage systems have become operational,new safety features have been mandated through various codes and standards,professional organizations, and learned best practices. The design and commissioning teams need to stay current so that required safety assessments can be performed during commissioning.

Do energy storage systems need to be listed?

It is critical for projects moving forward that execution teams understand that the International Fire Code (IFC),NFPA 855 and NFPA 70 (the National Electric Code) require energy storage systems to be listed, and that UL 9540 is the listing standard applicable.

Which components of a battery energy storage system should be factory tested?

Ideally, the power electronic equipment, i.e., inverter, battery management system (BMS), site management system (SMS) and energy storage component (e.g., battery) will be factory tested together by the vendors. Figure 2. Elements of a battery energy storage system
