How are EV charging stations funded?

These "key programs" are organized by administering agency. The Bipartisan Infrastructure Law (BIL) contains significant new funding for EV charging stations.

Are EV charging stations tax deductible?

If you purchase EV charging equipment for your principal residence, you may be eligible for a tax credit for the charging station. This credit is 30% of the cost of 1) the EV charging port, 2) components and parts that are essential to the operation of the charging port, and 3) labor for constructing and installing the charger, up to \$1,000.

Is EV charging an eligible expense under USDOT Surface Transportation Block Grant?

The law also makes the installation of EV charging infrastructure an eligible expense under the USDOT Surface Transportation Block Grant formula program.

Can I get a tax credit for EV charging equipment?

If you purchase EV charging equipment for a business, fleet, or tax-exempt entity you may be eligible for a tax credit. Starting on Jan. 1, 2023, the value of this credit is 6% of the cost of property subject to depreciation, with a maximum credit of \$100,000 for each single item of property.

Who is tax deductible for charging infrastructure?

Per a provision in the tax code, sellers/installers of charging infrastructure can be treated as the taxpayer, as long as they disclose the amount of the credit to the tax exempt/government entity. The buyer can then negotiate a lower upfront cost for the acquisition and installation of charging equipment.
