How are energy storage systems regulated?

In some contexts,for energy storage systems,compliance regulations take the form of a state adopting a code,which then references and requires testing and listing or adherence to a standard. Some cities,counties,and special administrative districts (e.g.,school or sewer districts) also adopt locally amended codes for their environments.

Does industry need energy storage standards?

As cited in the DOE OE ES Program Plan, "Industry requires specifications of standards for characterizing the performance of energy storage under grid conditions and for modeling behavior. Discussions with industry professionals indicate a significant need for standards ..." [1, p. 30].
