Another priority of the government of Equatorial Guinea in energy matters is the non-dependence of external sources for internal supply. In this way, efforts have been aimed at taking advantage of the renewable resources available in the country, this avoiding having to import row materials to cover future energy needs.

How much energy does Equatorial Guinea use?

Electricity consumption in Equatorial Guinea in 2015 was 36 kilotonnes of oil equivalent (ktoe). The country produces all of the energy it consumes. As of 2012, renewable energy accounted for 29.2% of the final energy mix.

How Equatorial Guinea's energy sector is evolving?
