

Who approves solar energy projects?

The Energy Commission (Suruhanjaya Tenaga, ST) and the Sustainable Energy Development Authority (SEDA) oversee the approval process for solar energy projects, requiring investors to obtain the necessary licenses before commencing operations.

Do utilities invest internationally?

For instance, the investment practices of utilities could be further investigated. Even though their inclination toward international investment seems to be limited in comparison to other investor types, they exhibit noteworthy levels of internationalization- despite their supposed focus on supplying energy domestically.

How do equity ownership restrictions affect solar energy projects?

Equity ownership restrictions also play a crucial role, as different solar energy programs, such as LSS PETRA and the Corporate Green Power Programme (CGPP), impose specific foreign ownership limits that investors must adhere to. Failure to comply with these regulations can lead to project delays, legal challenges, or even revocation of permits.

Do RE real asset investments converge with FDI patterns?

We find that over time, the trajectory of RE real asset investments increasingly converged with the patterns of FDI for onshore wind and solar photovoltaic (PV), but this was less so for offshore wind and biomass. This is probably driven by mainstreaming effects through financial learning for such technologies.
