What is a battery energy storage system?

Battery energy storage systems (BESS) stabilize the electrical grid, ensuring a steady flow of power to homes and businesses regardless of fluctuations from varied energy sources or other disruptions. However, fires at some BESS installations have caused concern in communities considering BESS as a method to support their grids.

Do ESS installations require additional large-scale testing?

In certain instances, ESS installations may require additional large-scale testing. Organizations may turn to alternative test methods for large-scale testing. However, these test methods are not widely accepted and should be considered on a case-by-case basis.

How many kWh can you put in a garage?

In all other locations noted above, the size limit is 80 kWh. On the exterior walls of the home, it's important to note that systems cannot go within 3 feet of doors or windows leading directly into the home. And as we will soon discuss, code compliance for ESS in an attached garage can be much more complicated than systems in a detached garage.
