

How much do solar panels cost in Georgia?

On average,installing solar panels in Georgia costs about \$19,635after taking into account the federal solar investment tax credit. That's roughly 17% more than the U.S. average of \$16,715. While solar panels in Georgia are relatively pricey,the savings over 25 years can add up to \$23,182. That can make it well worth going solar.

How much does a 5 kilowatt solar installation cost in Georgia?

Currently, the average price of 5-kilowatt solar installation in Georgia is between \$13,500 and \$12,733. That is the price before you claim the 30% federal tax credit. After the tax credit, the price comes down to about \$9,423, which equals approximately \$2.55 per watt.

What tax credits do solar panels get in Georgia?

The federal solar investment tax credit (ITC) is the biggest factor reducing the cost of going solar in Georgia. If you install a residential solar panel system by the end of 2032, you receive a federal income tax credit equal to 30% of the system's total cost. That includes equipment, labor and permits.

Does Georgia pay taxes on solar installation?

The cost of installing renewable energy systems in Georgia,including solar,is supported by the federal solar investment tax credit. This tax credit amounts to 30% of the value of the solar systemand is claimed on your taxes in the year following installation.

How much do solar panels cost?

The cost of solar panels in Georgia is currently lower than the average price of \$3.00 per wattacross the United States for residential solar power systems. The size of a solar panel system affects the installation cost, with larger installations having a lower cost per watt due to 'bulk pricing'.

Does Georgia have a solar rebate program?

As of January, Georgia doesn't have any local incentives or rebate programs. However, Georgia Power will buy back the excess energy a solar panel system creates at a rate less than the retail cost of energy.
