

How much energy does India need for a Bess system?

The Ministry of Power projects a need for ~41 GW/236 GWhof BESS capacity by 2031-32, signalling a shift from 2-hour systems to 4- and 8-hour solutions. Current tenders represent only ~5 percent of the projected demand for the next seven years, underscoring immense opportunities in India's transition to sustainable energy solutions.

With a decline of an average battery cost in the last 15 years, the cost and the decline in progress has accelerated the BESS expansion. India aims for 500 GW installed power capacity by 2030, achieving 217.62 GW by 2025. The government has committed to deploy 47 GW BESS by 2032.
