



# National Standard for Network Battery Cabinets

What are the safety requirements related to batteries & Battery rooms?

Employers must consider exposure to these hazards when developing safe work practices and selecting personal protective equipment (PPE). That is where Article 320, Safety Requirements Related to Batteries and Battery Rooms comes in.

Which NFPA codes require recombinant battery neutralization?

IFC 608.5; NFPA 1 52.3.5; IEEE-1188 4.2 IFC and NFPA1 codes require neutralization for VRLA batteries. IFC 608.5.2 states, "Recombinant battery neutralization.

When does a battery charger need a new energy conservation standard?

Compliance with the new standard is required on and after January 10, 2025. Effective March 10, 2020, the DOE adopted a new energy conservation standard for uninterruptible power supplies, a class of battery chargers. Compliance with the new standard is required on and after January 10, 2022.

What is the minimum clearance for a battery rack?

For battery racks, there shall be a minimum clearance of 25 mm (1 in.) between a cell container and any wall or structure on the side not requiring access for maintenance. Battery stands shall be permitted to contact adjacent walls or structures, provided that the battery shelf has a free air space for not less than 90 percent of its length.

Do cabinets with VRLA batteries need a sign kit?

In addition, cabinets with VRLA batteries have a separate requirement to identify the details of the battery system, electrical, chemical and fire hazards. Remember New York City B-29 Certificate of Fitness requires a specialized sign kit for all five boroughs.

How is battery room compliance interpreted?

Battery room compliance can be interpreted differently depending on your battery type, amount of cells or multi-cell units in a common area, volume of electrolyte and voltage present. Although the code is specific about requirements, the local interpretation can vary depending on the end users experience or awareness.
