

# Occupancy of photovoltaic

Which building types require a photovoltaic (PV) system?

All newly constructed building types specified in Table 140.10-A, or mixed occupancy buildings where one or more of these building types constitute at least 80 percent of the floor area of the building, shall have a newly installed photovoltaic (PV) system meeting the minimum qualification requirements of Reference Joint Appendix JA11.

Do I need to meter a photovoltaic system?

It is assumed that aluminum framed photovoltaic (PV) panels mounted on a "post" and rail mounting system, the most common in the industry today, will be installed by the homeowner. While metering the system is encouraged, the specification does not address system wiring elements for associated system sensors or monitoring equipment.

What is a occupied roof?

Occupied roofs as specified by CBC Section 503.1.4. Roof space that is otherwise not available due to compliance with other building code requirements if confirmed by the Executive Director.  $\text{kW PVdc} = \text{Size of the PV system in kW} \times \text{CFA} \times \text{A}$  = Conditioned floor area in square feet. A = PV capacity factor specified in Table 140.10-A for the building type.
