

# Overseas photovoltaic energy storage projects seek funding

Will Uzbekistan fund a 250-megawatt solar photovoltaic plant?

TASHKENT, May 21, 2024 -- The World Bank Group, Abu Dhabi Future Energy Company PJSC (Masdar), and the Government of Uzbekistan have signed a financial package to fund a 250-megawatt (MW) solar photovoltaic plant with a 63-MW battery energy storage system (BESS).

What types of funding programs are available for solar energy projects?

Funding programs encompass at least one research area: photovoltaics (PV), concentrating solar-thermal power (CSP), systems integration (SI), soft costs (SC), manufacturing and competitiveness (M&C), and solar workforce development (WF). How many energy storage projects were selected in Portugal's 2025 procurement?

A total of 43 projects were selected from 79 applications in Portugal's 2025 energy storage procurement. This included six projects from Spain's Iberdrola, which secured nearly EUR20 million (\$20.6 million) in public funding. From ESS News

Who is implementing the solar power plant project?

The solar power plant project will be implemented through a project company Nur Bukhara Solar PV LLC FE owned by Masdar, which is responsible for developing, financing, building, owning, operating, and maintaining the solar plant and BESS.
