Which PV products have reduced export tax rebate rates?

According to the above-mentioned government announcements,PV products included in the list of products with reduced export tax rebate rates are for PV cells, either installed or not in modules.

When will PV Manufacturing be re-exported to China?

The goal is simple: to map out PV manufacturing out to 2030 and beyond. Starting from 1 December 2024, the export tax rebate rate for some PV products and batteries will be lowered from 13% to 9% in China.

Will India's PV module exports decline in 2023?

The PV module exports from India to the U.S. have increased exponentiallyin the fiscal year (FY) 2023 (16x from FY2022 by value). In the backdrop of huge manufacturing capacities being set up in the U.S. under IRA,Indian PV module exports to the U.S. may experience a period of stagnation from 2025 and later decline from 2027 onwards.

How many dumping and import taxes are imposed on solar PV?

Since 2011,the number of antidumping,countervailing and import duties levied against parts of the solar PV supply chain has increased from just 1 import tax to 16duties and import taxes,with 8 additional policies under consideration. Altogether, these measures cover 15% of global demand outside of China.

Does solar PV decarbonise?

As power systems across the world decarbonise, the carbon footprint of PV manufacturing should shrink accordingly. Transporting PV products accounts for only 3% of total PV emissions. Meeting international energy and climate goals requires the global deployment of solar PV to grow on an unprecedented scale.
