How many batteries should be in a pack?

E.13 Under Packing Instructions 966 and 969, it states that "The maximum number of batteries in each package must not exceed the minimum number required to power the equipment, plus two spare sets. A "set" of cells or batteries is the number of individual cells or batteries that are required to power each piece of equipment".

How much battery do you need on a plane?

This is sufficient for most portable devices. Batteries between 100 Wh and 160 Whgenerally require airline approval before checking or carrying them on board. Carry-on requirement: Airlines typically prohibit battery packs in checked luggage. Keeping battery packs in the cabin reduces fire risks associated with lithium-ion batteries.
