What is energy settlement?

Energy settlement is the process of reconciling the difference between the energy purchased by energy suppliers from generators /producers and the energy sold to the customers. In this post we will analyse energy settlements, for both gas and power. We will begin with a brief introduction to the energy market and the principal participants.
