What is the Philippine Grid Code?

The Philippine Grid Code establishes and documents the basic rules, requirements, procedures and standards that govern the operation, maintenance and development of the high-voltage backbone transmission system in the Philippines.

How to submit data under the Philippine Grid Code?

GC 1.5.1.1 The submission of any data under the Philippine Grid Code shall be done through electronic formator any suitable format agreed upon by the concerned parties. GC 1.5.1.2 Written notices under the Philippine Grid Code shall be served either by hand delivery,registered first-class mail,or facsimile transfer.

What are the major power grids in the Philippines?

The company ensures that its services are available when and where it is needed. Composed of Metro Manila,North Luzon,and South Luzon,the largest grid in the country accounts for 74% of the country's total power demand. The interconnected island grids of Cebu,Negros,Panay,Leyte,Samar,and Bohol compose the Visayas grid.

How many kV transmission lines are there in the Philippines?

As of 2023,the Philippines' transmission network comprised about 15,316 ckt kmof transmission lines at voltage levels of 115-500 kV. Of this,43 per cent was at the 230 kV level,followed by 38 per cent at the 138 kV level. The transmission network grew at a CAGR of about 2.3 per cent between 2019 and 2023.
