

What is Poland's energy for rural areas program?

Poland has relaunched its Energy for Rural Areas program, offering loans covering up to 100% of solar installation costs in rural areas. The second funding round has a budget of PLN 1 billion (\$242.6 million).

Is Poland a good place to start a solar energy cooperative?

How many solar communities are in Poland?

As a result, although Poland's solar capacity has more than doubled in the last three years, only 30 of the EU's 9,000 energy communities are located in Poland.

How much solar power does Poland have?

As of the end of February 2025, Poland's installed grid-connected photovoltaic (PV) capacity reached 21.8 GW, an increase of 25.7% over the previous year. Solar energy accounts for about 64% of the country's total renewable energy capacity of 34.3 GW and about 30% of its total installed power capacity of 72.4 GW.
