The inverters shall comply with the IEEE 1547.4 "Guide for Design, Operation, and Integration of Distributed Resource Island Systems with Electric Power System" standard. While in the grid-interactive mode, the inverters shall be capable of four-quadrant operation (real and reactive power in and out of the inverter).
