What is the role of grid codes and standards in maintaining reliability?

The role of grid codes and standards in maintaining reliability requires wind and solar generation to tolerate small variations in grid frequency or voltage, to be able to provide voltage and frequency support, and to remain connected to the grid during large disturbances, such as the unexpected loss of a large power plant.

Can IEEE 2800 standards improve interconnection requirements for PV installations?

The IEEE 2800 standards have the potential to be as impactful as IEEE 1547-2003--the foundational standard in interconnection of distributed energy resources. The goal of this project is to develop streamlined and accurate methods for New York utilities to determine interconnection requirements for PV installations.

Are interconnection and interoperability technical standards effective?

In closing, 1547 and 2030 interconnection and interoperability technical standards continue to evolve as foundational documents helping accelerate the realization of the future grid. However, technical standards alone are not immediately effective unto themselves.

How do connected components affect the grid?

All connected components, from large power plants to smaller devices, can impact the grid in various ways. With increasing levels of distributed energy resources (DERs), the aggregate behaviors of these resources become as relevant as large power plants.
