

What are the pfcsa requirements for portable fuel containers?

In accordance with the Portable Fuel Container Safety Act of 2020 (PFCSA), portable fuel containers must comply with the requirements specified in § 1461.3, which are considered to be consumer product safety rules. § 1461.2 Definition. The definition of portable fuel container in the PFCSA (5 U.S.C. 2056d (b) (8)) applies to this part.

### What are the requirements for a portable fuel container?

Each portable fuel container manufactured for sale in the United States shall conform to one of the following applicable requirements. Containers sold pre-filled. Portable fuel containers sold pre-filled with a flammable liquid to the consumer must comply with the requirements of ASTM F3429/F3429M-24(incorporated by reference, see § 1461.4).

#### What are the requirements for a portable container?

Portable containers shall be metal, have tight closures with screw or spring covers and shall be equipped with spouts or other means to allow pouring without spilling. Leaking containers shall not be used. Flammable liquids may be dispensed in the open from a tank or from other vehicles equipped for delivering fuel to another vehicle only if:

### Are aboveground oil storage containers subject to SPCC?

No- Your facility is not subject to SPCC. Is the total aggregate capacity of aboveground oil storage containers greater than 1,320 gallons of oil? (Do not include containers less than 55 gallons, permanently closed container, motive power containers, or storage containers used exclusively for wastewater treatment.)

#### What are the zoning requirements for shipping container homes?

Zoning: Shipping container homes allowed in rural areas. Residential Use: Requires foundation permits. Storage Use: Allowed. Zoning: Minimal restrictions, one of the most container-friendly states. Residential Use: Allowed in most counties. Storage Use: No major restrictions. Zoning: Varies by county.

#### Why should fuel containers be secured?

Fuel containers shall be secured to prevent their being jarred loose, slipping or rotating. Containers shall be located to prevent damage to the container. If located within a compartment, that compartment shall be vented. Containers near the engine or exhaust system shall be shielded against direct heat radiation.

(Do not include containers less than 55 gallons, permanently closed container, motive power containers, or storage containers used exclusively for wastewater treatment.) ...

An onboard bulk storage container which is used to store or transfer oil for further distribution is not a motive



power container. The definition of motive power container does not include oil ...
