How much does electricity cost in St Kitts & Nevis?

The electricity rates in the Federation of St. Christopher (St. Kitts) and Nevis are \$0.26 per kilowatt-hour (kWh). This is lower than the Caribbean regional average of \$0.33/kWh.

Do I need a voltage converter in Saint Kitts and Nevis?

If the standard voltage in your country is in the range of 100 V - 127 V (as is in the US, Canada and most South American countries), you need a voltage converter in Saint Kitts and Nevis. You can find voltage converters at Amazon. You can also consider a combined power plug adapter/voltage converter.
