

How many solar power plants are there in Slovenia?

What is the potential of photovoltaic energy in Slovenia?

Slovenia offers great potentialfor exploiting photovoltaic energy due to evenly spread solar irradiation. The first photovoltaic power plant in Slovenia was set up in 2001. At the end of 2017,4,231 photovoltaic power plants had been installed in Slovenia with a total power of 267 MW.

Can Slovenia add 1 GW of solar power by 2025?

It is technically possible to add 1,826 MW in total. The review of the capacity of Slovenia's grid to include utility-scale solar power plants is primarily intended for investors, and it represents a tool to achieve the government's goal to add 1 GW of solar by 2025. It is also a part of the cabinet's wider push to increase the use of renewables.

How much will Slovenia spend on solar energy?

Slovenia has set aside EUR16 million (\$16.7 million)to support solar energy communities, requiring projects to include at least 100 kW of PV capacity, with or without storage. The program will run until 2027.

When will solar subsidy applications open in Slovenia?

Applications for the subsidy will open Mar. 18,2025. Slovenia's solar market slowed in 2024,but the residential segment maintained the largest share as it adjusted to the phase-out of net metering and a new electricity tariff system.

Where can photovoltaic facilities be integrated into a low-voltage network?

The greatest potential was recorded in the regions of Drava, Sava, Central Slovenia and Mura. The estimated potential for the integration of photovoltaic facilities into the low-voltage network is 795 MW. All five power distribution companies would have an almost equal share, according to SODO.
