Does battery energy storage qualify for a domestic content adder?

Given the current state of battery cell production in the United States, battery energy storage has largely been locked out of a financeable position on qualifying for the domestic content adder given the stated materiality of battery cells to a domestic content analysis.

Do home batteries qualify for tax credits?

Now, home batteries will only qualify for the 30% tax credit if they're purchased and installed by the end of the year before the credit phases out entirely. There is a bright spot: residential systems leased from third parties will remain eligible for tax credits beyond 2025, as they rely on 48E instead of 25D.

What tax credits are available for solar energy installations?

There are two federal tax credits that incentivize solar installations: (1) the Section 48 Investment Tax Credit (ITC) available to businesses who invest in solar energy systems; and (2) the Section 25D residential credit that may only be claimed by individuals who purchase a solar energy system or a standalone energy storage system for their home.

What is a battery energy storage system?

Battery energy storage systems (BESS) are often referred to as the game changer when it comes to delivering clean energy. Since 2005, the emergence of renewable energy resources like solar and wind has increased the intermittency of energy on the grid and the need for a resource to stabilize generation.
