What is the largest solar & energy storage project in California?

The California Energy Commission (CEC) is reviewing a pair of enormous solar +storage projects proposed by Intersect Power subsidiaries that,if constructed,would each become the largest in the United States. The top spot is currently held by Edwards & Sanborn Solar +Energy Storage,which fired up in Kern County,CA earlier this year.

What is arevon energy's eland solar-plus-storage project?

Arevon Energy 's Eland Solar-plus-Storage Project combines 758 megawatts (MWdc) of solar with 300 MW/1,200 megawatt hours of battery storage. Eland 1 reached commercial operation in December 2024,and Eland 2 recently commenced full operation. The two combined comprise 1.36 million solar panels and 172 lithium iron phosphate batteries (LFP).
