What is a federal subsidy for wind?

The primary federal subsidy for wind is a tax credit known as the production tax credit, or PTC, which offers wind facilities and some other renewables a small tax credit for every kilowatt hour of energy produced over a farm's first decade.

Should wind and solar subsidies be double this year?

According to an analysis by Cornwall Insight, an energy consultancy, subsidies to the developers of wind and solar over the next two years need to be at least double this year's record level if the government is to reach its clean power goal by the end of the decade. The London Times reports:

How much do wind subsidies cost?

That year, taxpayers spent \$56 in subsidies for every megawatt hour of wind energy produced, compared to just 64 cents for electricity from coal or natural gas. According to the EIA, 97% of those wind subsidies came from the American Recovery and Reinvestment Act of 2009.
