How are tariffs calculated in Zambia?

The calculation of tariffs in Zambia is typically based on a percentage of the customs value of the goods, which is determined through the cost, insurance, and freight (CIF) valuation method. How to export goods outside Zambia?

Registration An exporter wishing to export goods outside Zambia must register with the Zambia Revenue Authority for a Tax Payer Identification Number (TPIN). Those wishing to export under preferential treatment (SADC, COMESA, etc) should also register with the Customs Services Division in the department of International and Policy.
